### Descendants of RICHARD KIDD the 3rd (1750-1838)

MILLER, OF GODALMING IN THE COUNTY OF SURREY, BY HIS WIFE DEBORAH  
WARING (1750-1834)

---

**Richard Kidd** the 3rd was born at Godalming 12 December, 1750. He was a son of Benjamin Kidd the 1st\* of Godalming by his wife Ann Westbrook, of whom an account is given in *Chapter XV*. It is sufficient to repeat here that Ann Westbrook was a daughter of James Westbrook by his wife Rebecca Bax the 4th, who was a daughter of Edward Bax the 1st of Ockley Court (who died in 1726) and a granddaughter of Thomas Bax the 1st of Kitlands (who died in 1691).

Richard Kidd's paternal grandparents Richard and Mary (Adams) Kidd had died many years before he was born, as had also his maternal grandfather James Westbrook. His maternal grandmother, Rebecca Bax, had married secondly James Hunt of Godalming, and she died there in 1765, when Richard Kidd was fifteen years of age. James Hunt died there some two years later.

At a Friends Meeting held at Godalming 9 June, 1774, Richard Kidd the 3rd, then a mealman of Guildford, was married to Deborah Waring, daughter of Elijah and Sarah Waring of Godalming. Elijah Waring (1725-96) was a surgeon at Alton in Hampshire, and later at Godalming. Between 1775 and 1790 twelve children were born to them, all save the eldest at Godalming. In 1796 Richard Kidd's mother, Ann (Westbrook) Kidd, died at Godalming, and in 1800 his father, Benjamin Kidd, died there.

His wife, Deborah (Waring) Kidd, was born 19 October, 1750, and died at Godalming 6 March, 1834, aged eighty-four years. Richard Kidd died 24 April, 1838, aged eighty-seven years; he is described in the Quaker records both as mealman and as miller. He was great-nephew to Benjamin Kidd, the celebrated Quaker Minister, who is further described in the *Note on the Kidd Family* appended to *Chapter XV*.

\* No connection has been traced between this family and Benjamin Kidd, the late author of *Social Evolution* and *The Science of Power*. His son, Dr. Franklin Kidd, the Director of the Low Temperature Research Station at Cambridge, tells me that he cannot at present trace his ancestry beyond his own grandfather.

Deborah (Waring) Kidd is said to have been related to Anna Letitia Waring, the hymn writer.

Richard and Deborah (Waring) Kidd had issue—

- 10 **John Kidd** the 3rd, born at Godalming 21 January, 1787; died 24 November, 1846, unmarried, and was buried at Godalming.
- 11 **Waring Kidd**, born at Godalming 23 February, 1789, and resided at The Hatch, Godalming. He died 19 December, 1884, and was buried at Godalming. He married firstly Martha Ann Patrick, who died without issue; and secondly Jane Perry, who died 7 February, 1889, and was buried at Witley Churchyard: by her he had an only child—
  - (1) **Henry Waring Kidd**, who died unmarried 23 March, 1884, and was buried at Witley Churchyard.
- 12 **Samuel Kidd**, born at Godalming 16 March, 1790; died 27 March, 1867, and was buried at Godalming Old Cemetery. He married Mary Bloomfield, whom he met in America. In 1821 his second cousin Elizabeth Prichard of *Pedigree 8* wrote of an expedition to New Harmony, Indiana, with Samuel Kidd and his wife. (*Records of the Southall Family*, 1932, by Celia Southall, p. 31.) He founded the firm of Samuel Kidd & Co. Ltd., flour millers, of Isleworth, and left a considerable fortune to the Hallam family.

## Section A

**Deborah Kidd** the 1st, daughter of the Richard and Deborah (Waring) Kidd who appear at the head of this pedigree, was born at Godalming 2 August, 1777. She was married at a Friends Meeting at Godalming 4 July, 1801, to Edward Hallam the 1st, Junior, of Bury, son of Edward and Abigail Hallam of Bury. Deborah (Kidd) Hallam of Bristol died 28 January, 1854, aged seventy-seven. It is said that Edward Hallam was related to Tennyson's friend Arthur Henry Hallam, who was son of Henry Hallam, the historian, and grandson of John Hallam, at one time Dean of Bristol.

Edward and Deborah (Kidd) Hallam had issue—

Section A-2

Sarah Waring Hallam, daughter of the Edward and Deborah (Kidd) Hallam described under *Section A*, was born 8 June, 1808, and died in 1857. She married William Naish the 1st, who was born 12 July, 1806, and died 28 July, 1875. He was a sewing-cotton manufacturer at Castle Street, Bristol, and lived latterly at Weston-super-Mare. He was Mayor of Bristol in 1864, and in that capacity opened the Clifton Suspension Bridge; Lord Palmerston was to have performed the ceremony, but fell ill at the time. William Naish belonged to the Quaker family of that name, but in later life joined the Church of England. He married secondly Catherine Stott, by whom he had one child, Percy Llewellyn Naish, who was living in 1932 with his wife and daughter at Paveys, Heatherside, Camberley, Surrey.

William and Sarah Waring (Hallam) Naish had issue—

- 1 William Naish the 2nd, who as a young man emigrated to Australia, and married there. A daughter of his was seen in the early years of the present century on a visit to Australia made by a great-niece of his father.

Edward Hallam, son of the Edward and Deborah (Kidd) Hallam described under *Section A*, was born 9 September, 1812. He lived at Axbridge, and attended the

Friends Meeting at Sidcot, and died in 1867. He married Elizabeth Strode, who was born in 1799, and died 2 December, 1875. She traced her descent from William Strode, one of the five Members of Parliament impeached as traitors in 1642 by Charles I. Edward and Elizabeth (Strode) Hallam had issue—

- 1 **Elizabeth Margaret Hallam**, born 2 September, 1842; married at Guildford 2 September, 1869, Samuel Ashby Sholl, who was born 6 May, 1836. She died at Axbridge in September, 1910, and he died at Caterham. He was a flour miller, first at Congresbury in Somerset, and afterwards at Godalming, son of Samuel Sholl of Brixton and grandson of John Sholl of Spitalfields. (*See Note on the Sholl Family at the end of this pedigree.*) *Issue*—
  - (1) **Margaret Deborah Sholl**, born 26 October, 1871, and in her literary work uses the name "Margaret Hallam". She married the Rev. ## Section B

**Edward Kidd** the 1st, son of the Richard and Deborah (Waring) Kidd who appear at the head of this pedigree, was born at Godalming 24 October, 1778, and died 3 June, 1858, aged seventy-nine, when of Clifton, near Bristol. He married Mary Briant, who was born 6 October, 1777, and died 3 June, 1868, aged ninety, when of Clifton.

Edward Kidd had the old mill at Godalming, but moved to Bristol about 1818, and took the old mill on the Avon at Temple Meads. This was a flour mill when wheat was stone-ground, but when roller mills came into use it became a grist mill for grinding barley, oats, etc. He erected there one of the early steam engines\* in the city, and he had also veneer cutting mills adjoining. He was one of the twelve commissioners appointed by the Crown to settle the claims for damage done by the mob at the Bristol Riots.

Edward and Mary (Briant) Kidd had issue—

**Section C**

**Benjamin Kidd** the 2nd, son of the Richard and Deborah (Waring) Kidd who appear at the head of this pedigree, was born at Godalming 8 August, 1783, and died when of Godalming, 30 January, 1858, aged seventy-four; a mealman. In 1933 there was a tombstone in the Friends Graveyard at Godalming showing his name and that of his wife. He married 12 March, 1818, Caroline Driver, who was born 26 August, 1792, and died when of Godalming 3 June, 1863, aged seventy.

Benjamin and Caroline (Driver) Kidd had issue—

- 1 **CAROLINE KIDD** who married Charles John Woods: *see Section C-1*.
- 2 **Benjamin Kidd** the 3rd, born at Godalming 15 November, 1820. He resided at Bramley, and died without issue. He married Marian Chandler, whose brother Alfred Thomas Chandler married Benjamin Kidd's sister, Ann White Kidd. The following is an extract from a letter written by Canon R. P. Moline of *Pedigree 7* from North Cadbury Rectory on 18 March, 1933:—

“I have been intensely interested in the information you have so laboriously collected; much of it brings to mind boyish recollections—particularly the Kidd pedigree. Pedigree 6, Section C, is of special interest to me, partly because the Chandlers (brother and sister) who married respectively Ann White Kidd and Benjamin Kidd were personally well known to me, and their elder brother Allen was my godfather, being a first cousin of my mother. His son Allen was my personal friend, and at one time Captain of the Surrey County Cricket Club, and President of the Royal Rose Society.

“The aforesaid Ben Kidd married Marian Chandler, and I used to visit them at Bramley, near Guildford. His hobby was astronomy, and he had a large telescope kept in a sort of garage, from which it could be wheeled on rails to an open space. Ben spent most clear nights on this spot with his telescope, and if there was a transit visible, or a distant comet came into view, he would ring up the household—his wife and servants—and insist upon their looking through the telescope, even though snow was on the ground.



Marian gave up going to bed at night, and slept during the day. She was portly, and very short of stature, and on one occasion fell on a round flower-bed much raised in the middle, from which she was unable to rise until, after some hours, her deaf husband came to her assistance.

“ This branch of the Kidd family was generally deaf. Ben told me it was an inheritance from an ancestor of the name of Heath. I do not see his name in your pedigree, but I remember a deaf gentleman of that name who used to lecture to us at Cranleigh School on astronomy : he also became a benefactor, building the school laboratory.

“ Annie Chandler—née Kidd—was almost stone deaf. She lived at Farncombe (Godalming) in 1871, her husband being dead. Her son George (named after my grandfather, George Haines) was an auctioneer. The father, Alfred Chandler, had been a doctor of medicine. I remember seeing an amusing cartoon by a Henry Daubeny, showing a youngish man in the likeness of Alfred Chandler dragging by a halter a reluctant nannie-goat along Godalming High Street, with the spire of the church in view. Its meaning was clear to those who knew that Alfred Chandler had again and again proposed to Annie Kidd before his importunity became successful.”

The deaf astronomer named Heath who used to lecture to Canon Moline at Cranleigh was Douglas Denon Heath of Kitlands in Capel, Senior Wrangler and Smith Prizeman, who died unmarried in 1897 : he was a son of George Heath, Serjeant-at-law, who bought Kitlands from William Bax in 1824.
