Caroline Kidd, daughter of the Benjamin and Caroline (Driver) Kidd described under *Section C*, was born at Lanaway, Godalming, 4 January, 1819, and died in the eighteen-eighties. She married Charles John Woods of Godalming.

- 1 **Henry Charles Woods**, born 1841, and died in 1931 at Lisnamandra, Alverstoke, Gosport. He married in 1868 Elizabeth Kennedy, daughter of Col. Kennedy of the Royal Artillery. James Kidd the 3rd, son of the Benjamin and Caroline (Driver) Kidd described under *Section C*, was born at Godalming 9 July, 1824, and died in 1874. He lived at Lewes in Sussex. He married Mary Davy of Ringwood in Hampshire, who was born in 1831 and died 2 January, 1897.

James and Mary (Davy) Kidd had issue—

Section D

Lydia Kidd, daughter of the Richard and Deborah (Waring) Kidd who appear at the head of this pedigree, was born at Godalming 4 August, 1785, and died at Stoke Newington 22 July, 1877, being buried at Winchmore Hill, aged ninety-two. At a Friends Meeting held at Godalming 10 August, 1810, she was married to John Sparks Moline the 1st of Leadenhall Street, London, son of Sparks Moline the 1st of Leadenhall Street by his wife Rebecca Gulson. John Sparks Moline of Adelaide Place, near London Bridge, merchant, and of Cobham Farm, West Ham, co. Essex, gentleman, was born at Chapel Street, Westminster, 27 July, 1786, and died at Adelaide Place 25 November, 1836, aged fifty. His uncle, Robert Moline, had married in 1786 Elizabeth Kidd, aunt to Lydia (Kidd) Moline; their descendants are described in *Pedigree 7*, to which is appended a *Note on the Moline Family*.

John Sparks and Lydia (Kidd) Moline had issue—

Sparks Moline the 2nd, son of the John Sparks and Lydia (Kidd) Moline described under *Section D*, was born at West Ham 12 May, 1811, and died at Stoke Newington 28 November, 1865, aged fifty-four; buried at Winchmore Hill. He married at Kingsbridge, co. Devon, 8 November, 1838, Isabella Prideaux, daughter of William Prideaux by Mary Coles his wife. She died at Stoke Newington 4 October, 1840, aged twenty-three, and was buried at Winchmore Hill.

Sparks and Isabella (Prideaux) Moline had issue—

- 1 **Isabella Prideaux Moline**, born at Stoke Newington 20 September, 1840; residing there unmarried in 1896. The following is extracted from *The Friend* of 16 November, 1923: "Isabella Prideaux Moline, who died at Bournemouth (Boscombe) on 30th October, 1923, aged 81, although not herself a Friend, was nearly the last of an old Quaker family in which longevity was conspicuous. . . . Through her mother, I. P. Moline was nearly related to the late Col. W. F. Prideaux, once a captive in Abyssinia, to Dr. Prideaux Tregelles, the biblical scholar, and to Joseph Anstice, the hymn writer. By her grandmother she was connected with the Kidds of Bristol . . . and with Anna Letitia Waring. A few Molines still live in Austria. I. P. Moline's branch of the family settled at Stoke Newington 100 or more years ago. Thomas Wilkinson, in his poetic account of Friends in and about London in 1836, writes:

'With Birkbeck, Philipps, Fell and West I dine,
Or plunge in rural scenes with Sparks Moline.'

For most of that time the family has lived in 6 Church Row. There, surrounded with Italian paintings and portraits of her family and of her father's friend Joseph Meston of Bath, she passed a beautiful old age. She was one of the last of the old inhabitants of Stoke Newington, and printed a few pages of reminiscences of it some years ago. Among her treasures was a curious antique black lacquer cabinet, traditionally belonging to Gulielma Springett before her marriage with William Penn, which had been previously in the Gulson family of Leicester for 150 years or more. This she gave to Friends at Jordans, where it now is." It will have been observed that her paternal grandmother was Rebecca Gulson. The surname "Moline" is now usually pronounced to rhyme with "dean".

Section D-2

David Moline, son of the John Sparks and Lydia (Kidd) Moline described under *Section D*, was born at West Ham 11 August, 1814. He settled at Laybach in Austria, and died at Zirknitz in Austria 7 October, 1864, aged fifty. He married in Austria Gertrude Podjoy, who died at Laybach in 1851.

David and Gertrude (Podjoy) Moline had issue—

- 1 **John Sparks Moline** the 2nd, born 15 December, 1845, and married Stephanie Augusta Blatties. They resided in Austria, and it is thought that their descendants have lost touch with their English kinsfolk. *Issue*—

I. NOTE ON THE SHOLL FAMILY

It has been stated, under *Section A-3* of this pedigree, that Elizabeth Margaret Hallam, daughter of Edward Hallam by his wife Elizabeth Strode, married in 1869 Samuel Ashby Sholl, grandson of John Sholl of Spitalfields. Miss Elizabeth P. Sholl, of Caerleon, Yatton, Somerset, a granddaughter of the said John Sholl, has courteously supplied many of the particulars given in that section. In October, 1929, she published in the *Friends Quarterly Examiner* an interesting account of her grandfather, who was born in 1777 and died in 1845. He was a convert to Quakerism, of a stern, uncompromising nature, but possessing an interesting and arresting personality. He lived in Elder Street, Spitalfields, and was prominent as a silk weaver and inventor of silk looms; he made figured silks for wealthy buyers, including George III, the Prince Regent, William IV, Queen Charlotte and Queen Adelaide. An account is given of the occasion when the Prince Regent took his seat in Westminster Meeting dressed as a woman Friend. Although before their conversion to Quakerism John Sholl had been a proficient player on the violin and his wife accustomed to sing, after that event, as was then customary, he dealt severely with any member of the family who even ventured to hum a tune. He had a long and violent quarrel with the Right Hon. W. Huskisson, then President of the Board of Trade; he had varied adventures in America in the eighteen-thirties; one of his designs in figured silk for the fashionable parasols represented the trial and condemnation to death by Brutus of his own sons for a breach of discipline; but his most striking achievement was the invention of a beehive from which the honey could be removed without destroying the bees. Prince Albert ordered several to be sent to Windsor, where the inventor was asked to explain their construction to the Queen and the Prince.

In the issue of *Punch* for Wednesday, 14 August, 1844, there is a cartoon in which the royal pair are seen standing before the hives in the Castle grounds, the Queen bending down to watch the movements of the workers within the glass, which take the form of British workmen, the accompanying letterpress explaining that "The Royal beehives are formed after the most approved political principles, albeit the said

principles have not yet come into general fashion. They are so constructed that the working bees within (they are a very curious species of bee and bear an outward resemblance to British mechanics and artificers) are carefully deprived of all honey they elaborate save the honey that is considered sufficient to afford them ample sustenance in all seasons. Thus it will be seen that the Bees pay a very large property tax, but unlike too many of their fellow-subjects they are left enough to eat in return for their labours. *All* is not taken from them." The inventor's seal, bearing the legend *nihil sine regina* round the figure of a queen bee, was noticed by the Prince. One morning, when driving the Queen in his phaeton through Hyde Park, he caught sight of John Sholl taking exercise there, and called out pleasantly, "Good morning, Mr. Sholl; nothing without a Queen."

II. NOTE ON THE CAPPER FAMILY

Since all numbered persons in *Section B-1* of the preceding pedigree are descended from the Capper family, some particulars of that family are given below. They are chiefly derived from two very large printed charts drawn up in 1875 by Arthur John Naish and Walter Capper and lent me in 1935 by Mr. C. E. Kidd of Portishead.

William Capper the 1st, a copyholder near Rugeley in Staffordshire, died 2 February, 1590. He married Anna . . . who died 22 February, 1608. They had, among other issue—

Thomas Capper, who was married 17 October, 1603, to Katherina Kenwirke, and had, among other issue—

Richard Capper, who was born 22 January, 1619, and had, among other issue—

John Capper of Rugeley, who was baptized 5 January, 1661, and buried 21 April, 1725. He was married 16 January, 1688, to Judith Padmore, who died 22 September, 1724. He erected at his own cost a gallery on the north side of Rugeley Parish Church, and had, among other issue—

John Capper the 2nd of Rugeley and of Bunning's Mill, near Lichfield, who was born 4 February, 1690, and married Sarah . . . who died 4 October, 1766, having had, among other issue—

William Capper the 2nd, who was born at Rugeley 30 April, 1720, and died 2 April, 1785. He was married in 1746 to Rebecca, daughter and ultimately heiress of John Smallwood. She was born in 1724, and died 6 December, 1793. They

were both buried in Vault No. 26 at St. Mary's, Birmingham, having had, among other issue—

Jasper Capper, who was born at Rugeley 19 May, 1751, and died at Stoke Newington 24 December, 1819. He was married 21 April, 1778, at the Friends Meeting House at Whitechapel, to Anne, daughter of John Fry. She was born 14 August, 1756, at Melksham, and died at Stoke Newington 19 November, 1821. They had, among other issue—

- 1 **Samuel Capper**, who was born 2 March, 1782, and died 29 August, 1852. He was married 2 February, 1803, to Elizabeth Naish, who was born 22 November, 1781, and died 1 March, 1864. They had, among other issue—
 - (1) **Rebecca Capper** the 1st, who married Edward Kidd the 2nd of *Section B* of the preceding pedigree, wherein her children are described.
 - (2) **Martha Gundry Capper**, who married Richard Kidd the 4th of *Section B-1* of the preceding pedigree, wherein her descendants are described.
- 2 **Rebecca Capper** the 2nd, who was born 11 May, 1783, and died 9 November, 1817. She was married 24 October, 1804, to Paul Bevan, who was born at Swansea 30 August, 1783, and died 12 June, 1868. They had, among other issue—
 - (1) **Mary Bevan**, who was born 25 October, 1805. She was married 16 July, 1829, to Alfred Waterhouse of Liverpool, who was born 15 June, 1798, and died 27 December, 1873. They had, among other issue—
 - i. **Alfred Waterhouse**, the distinguished architect and Royal Academician, who was born 19 July, 1830, and was married 8 March, 1860, to Elizabeth Hodgkin.
 - ii. **Edwin Waterhouse**, a former President of the Institute of Chartered Accountants and member of the firm of Price, Waterhouse & Company of London. He was born 4 June, 1841, and was married 3 April, 1869, to Georgina Emma Catherine Thöl, who was born 30 October, 1848. They had, among other issue—
 - (i) **Sir Nicholas Edwin Waterhouse**, K.B.E., a former President of the Institute of Chartered Accountants.* (*Who's Who*, 1935.)
- 3 **Anne Capper**, who was born 20 September, 1784, and died at Sunderland 20 March, 1850. She was married 12 October, 1803, to Thomas Robson, who was born at Darlington 20 January, 1779, and died at Sunderland 14 April, 1853. They had, among other issue—
 - (1) **Edward Capper Robson**, who was born 12 September, 1812, and was married, secondly, 15 April, 1852, to Priscilla Tuke, daughter of Samuel Tuke the 1st by his wife Priscilla Hack the 1st. See the *Note on the Hayllar, Hack and Tuke Families* appended to *Pedigree 13*.

* In 1911-12 it was my privilege to work for Sir Nicholas Waterhouse in London and in Germany. His uncle, Alfred Waterhouse, designed the house now known as Harborgill at Great Ayton in which my parents have lived since their marriage forty-nine years ago. My father bought it from the late Jonathan Backhouse Hodgkin and his wife, who owned the Cleveland Lodge estate which formerly belonged to her father, John Pease, and before that to Thomas Richardson, the founder of the Friends' School at Great Ayton and the Richardson of Richardson, Overend & Gurney, the Quaker bill-brokers of London.

- 4 **Frances Capper**, who was born in London 4 August, 1788, and died 20 June, 1862. She was married at Gracechurch Street Meeting 15 December, 1813, to William Naish, who was born 9 March, 1785, and died 4 March, 1860. They had, among other issue—
- (1) **Arthur John Naish**, who was born at Bath 21 January, 1816, and was married at Tavistock 7 October, 1847, to Margaret Prideaux Paull, who was born 11 January, 1825, and died 25 February, 1880. They had, among other issue—
- i. **Charles Ernest Naish**, who married Alice Rebecca Kidd of *Section B-1* of the preceding pedigree, wherein her descendants are described.
